Dear Tribal Leader:

Please join us in commemorating the 15th Anniversary of the Native American Graves Protection and Repatriation Act in Albuquerque, New Mexico on November 15-16, 2005. The National Association of Tribal Historic Preservation Officers (NATHPO), which is a national non-profit membership organization of tribal governments from around the country, is serving as the coordinator for this historic event.

On November 16, 1990, the Native American Graves Protection and Repatriation Act (NAGPRA) directed federal agencies and museums in receipt of federal funds to work with tribal governments in returning Native American human remains and certain cultural items. Prior to this Act, collection of human remains and sacred items and objects of cultural patrimony were collected by various means and Native people were disenfranchised from asserting our cultural property rights. In the 15 years since its passage, over 31,000 ancestors have been identified for repatriation with 627,323 associated funerary objects. Federal agencies and museums have given notice of intent to repatriate 87,105 unassociated funerary objects, 3,413 sacred objects, and 981 objects of cultural patrimony.

NATHPO is convening a National Meeting of tribal representatives to discuss how NAGPRA has served their communities, as well as highlight some remaining challenges. We are currently compiling a summary that documents the many success stories (see attached form) that were a direct result of NAGPRA. NATHPO is also coordinating an Evening Reception at the Indian Pueblo Cultural Center on Wednesday, November 16, 2005, which is the 15<sup>th</sup> anniversary of when the Act was signed into law (November 16, 1990).
