# ABOUT NATHPO

Founded in 1998, NATHPO is a non-profit membership organization that supports and encourages tribal historic preservation programs.

Tribal Historic Preservation Officers (THPOs) have the responsibilities of State Historic Preservation Officers on tribal lands, grounded in self-determination, traditional knowledge, and cultural values. THPOs advise and work with federal agencies on the management of Tribal historic properties, and they preserve and rejuvenate the unique cultural traditions, practices, and languages of their Tribal communities. THPOs also frequently implement NAGPRA to bring home stolen ancestors and cultural objects.

**NATHPO** is guided by three main principles:

- **Tribal Sovereignty:** the inherent right of Indian Nations to self-government
- **Confidentiality:** recognition of the need to respect the confidentiality of information regarding Native cultural and ceremonial practices and places of religious or cultural significance.
- **No boundaries:** NATHPO recognizes that the cultural and heritage preservation interests of Indian Nations and their peoples often extend far beyond the boundaries of present-day reservations — often crossing state and national boundaries — and stands ready to assist in activities relating to transboundary cultural and environmental issues

**Tee Wakąçak (Devil's Lake State Park)**

The state's most popular state park, drawing nearly 3 million annual visitors. Encompassing over 10,000 acres, Devil's Lake is part of over 27,000 acres of public recreational land in Sauk County. The park, also known as "Tee Wakąçak", meaning Holy or Sacred Lake, is situated on ancestral Ho-Chunk land and contains ancient effigy mounds that are part of their cultural heritage.



**Maa Wákąçak (Badger Ammunition Plant)**

Once hailed as the world's largest ammunition plant and having been turned back over to its rightful caretakers, the Hooçak (Ho-Chunk), the Badger Ammunition plant built in 1941, would see munitions productions for several wars before being closed and considered excess to the Department of the Army. Today, over 1500 acres of the former Badger Ammunition is managed and overseen by the Hooçak Nation via a land transfer. Renamed Maa Wákąçak (Holy land), the tribe has realized, for a lack of better terms, a cultural rebirth. Prairie and wildlife restoration have been in the forefront in the Hooçak Nation's plan for the property, and recently a cooperative art project led by the Little Eagle Arts Foundation.



**Kingsley Bend Indian Mounds**

Since 2006 Kingsley Bend has been owned and maintained by the Ho-Chunk Nation. Under the nation's care the preserve is undergoing a major restoration project including not just the public areas but restoration of oak savanna and native prairie as well. The mounds themselves are maintained according to protocols developed along with the Ho-Chunk Nation that dis-allow mowing of the mounds, but instead a healthy ground cover is maintained to slow erosion. For visitors to the site this means that the shapes of the mounds are easily identifiable. Keep in mind that this is not just a historical site, but a religious one as well. It needs not be said that visitors should be respectful and not walk on the mounds.



**Man Mound National Historic Landmark**

A unique and invaluable site, as it is the only man-shaped effigy mound left on Earth. Located in Sauk County, Wisconsin, this ancient earthwork offers a rare glimpse into the cultural and spiritual practices of the Native American societies that built it over a thousand years ago.

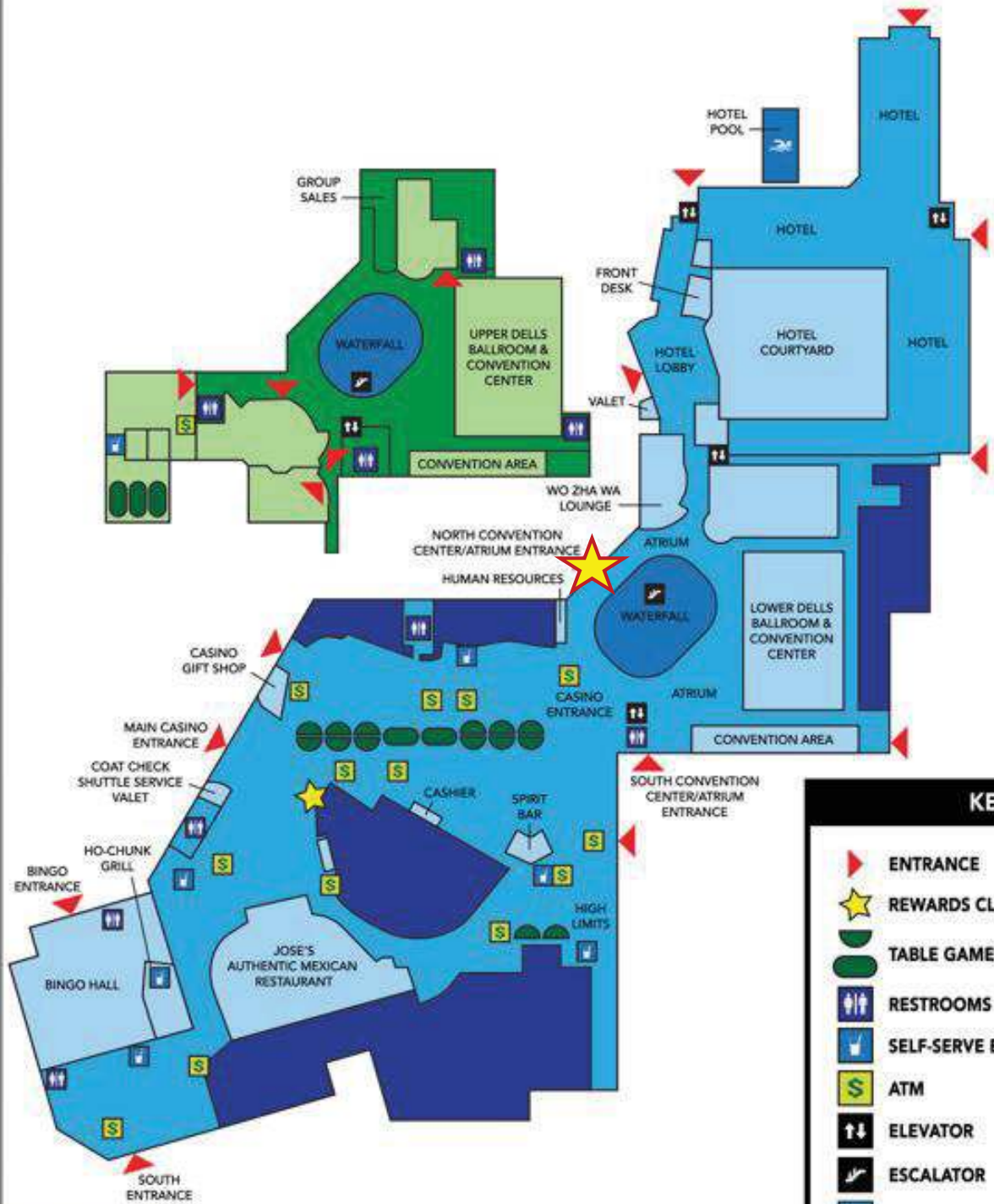
