UPCOMING COMMENT DEADLINES AND CONSULTATIONS

COMMENT DUE TODAY, 7/22/24 | Draft DHS Environmental Justice Strategic Plan: The Department of Homeland Security (DHS) is revising its Environmental Justice (EJ) Strategy (Fiscal Year 2021-2025). HAPPENING JULY 23 & 24: NPS Draft Consultation Policy: The National Park Service (NPS) is soliciting feedback from Tribal representatives as to proposed edits/recommendations on how the NPS Tribal Consultation policy will best serve the needs of Indian Country. The draft policy includes the requirements within President Biden's Memorandum on Uniform Standards for Tribal Consultation released at the 2022 Tribal Summit. The draft also covers various divisions within NPS that work closely with Tribal Nations. NPS will be holding two Tribal consultations - one on July 23, 2024, and another on July 24, 2024, both at 3:00 PM Eastern. FEMA Public Assistance Program and Policy Guide Update - Tribal Consultation August 7 & 8, 2024. The Federal Emergency Management Agency (FEMA) is inviting Tribal Nations to attend virtual consultations on FEMA's Public Assistance Program and Policy Guide Update. The agency is soliciting feedback on proposed updates to Version 5 of the Public Assistance Program and Policy Guide (PAPPG). The 60-day comment period ends August 19, 2024. NATHPO will be submitting comment, which we will post <u>HERE</u> when it is finalized.

EPA Tribal Oil Spill Prevention Webinar - August 21 & September 17: The Environmental Protection Agency (EPA) is hosting two more 90-minute sessions that provide a basic overview of the Spill Prevention, Control and Countermeasure (SPCC) oil spill prevention program, regulatory requirements, program implementation, and federal oil spill reporting requirements. The session will also include a question-and-answer segment where participants can interact with the SPCC national program manager. NATHPO STANDS WITH TRIBAL NATIONS DEPRIVED OF MEANING CONSULTATION IN THE SAN PEDRO VALLEY

A Newly-Filed "Friend Of The Court" Brief Seeks To Hold Federal Officials Accountable For Failing To Consult With Tribes Before Beginning Construction Of A New Transmission Line Impacting Their Sacred Places.

On Monday, July 29, 2024, The National Association of Historic Preservation Officers (NATHPO) <u>filed an amicus brief</u> in support of the Tohono O'odham Nation and the San Carlos Apache Tribe in their lawsuit against the U.S. Department of the Interior (DOI) for failing to properly consult with the Tribes under Section 106 of the National Historic

Preservation Act (NHPA).

The NHPA requires federal agencies to consult with Tribes before embarking on projects that could harm places of religious or cultural importance and consider alternatives to avoid or mitigate that harm. In this instance, the Tribes were not consulted until *after* DOI had allowed SunZia Transmission, LLC, to begin construction on a transmission line running through the San Pedro Valley, which runs between the Tohono O'odham Nation and the San Carlos Apache Tribe and is of great importance to both communities.

"Meaningful consultation means allowing a conversation to happen at a point where outcomes and solutions like re-routing or even canceling a project remain on the table. In this case, that simply did not happen. The Department of Interior failed in its duty to the affected Tribal Nations when it authorized construction through a landscape-level traditional cultural property and only then, as construction began, met with the Tohono O'odham Nation and San Carlos Apache Tribe," said NATHPO Executive Director Valerie J. Grussing, Ph.D.

Represented by the Native American Rights Fund (NARF), NATHPO argues in the brief that the federal government owes Tribal Nations special consideration when it considers projects' potential effects to places of cultural and historic significance.

"Section 106 of the NHPA requires federal agencies to engage in meaningful consultation with Tribal Nations early in the planning process so that measures to avoid adverse effects to culturally important places can be fully developed and considered. The federal government cannot wait until after it approves construction to start consulting with Tribal Nations," said NARF Staff Attorney Wesley James Furlong.
